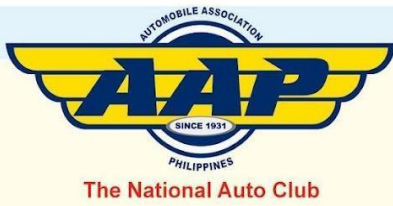
Nominees should meet the following criteria:
